SHELTER - WE OFFER A CONTINUUM OF SERVICES FOR WOMEN, MEN, AND CHILDREN IN OUR SIX COUNTY SERVICE AREA. OUR PROGRAM SERVICE MIX IS DESIGNED TO ASSIST CLIENTS FROM CRISIS TO STABILITY. WE PROVIDE A CRISIS SHELTER FOR FAMILIES FLEEING THEIR HOMES DUE TO DOMESTIC VIOLENCE. OUR CRISIS SHELTER IS COMPRISED OF STAFF AROUND THE CLOCK ASSISTING CLIENTS WITH IDENTIFYING THEIR NEEDS, CONNECTING TO RESOURCES, AND PLANNING FOR A SAFE FUTURE. 466 CLIENTS WERE ASSISTED THROUGH OUR PROGRAMS AT THE SHELTER. OUR TWENTY FOUR HOUR CRISIS LINE, WHICH HANDLED 3203 CALLS IN 2017, IS STAFFED WITHIN THE SHELTER PROGRAM.

HOPE HOUSE PROVIDED 82 HOMELESS, CHEMICALLY DEPENDENT WOMEN WITH SUPPORTIVE SERVICES TO HELP THEM MAINTAIN RECOVERY AND BECOME SELF-SUFFICIENT. THOSE SERVICES INCLUDE CASE MANAGEMENT, PEER RECOVERY SUPPORT, EMPLOYMENT TRAINING, FINANCIAL MANAGEMENT, PARENTING, AND HOUSING. DURING THE MOST RECENT FISCAL YEAR 51% REMAINED IN THE PROGRAM AT LEAST 60 DAYS. THE HOPE HOUSE PROGRAM MOVED INTO THEIR NEW LOCATION AT YWCA NORTHEAST INDIANA IN MARCH OF THE MOST RECENT FISCAL YEAR.

GROUPS MEET WITHIN JAILS IN NORTHEAST INDIANA, AND AHOMELESS SHELTER/RECOVERY HOME. THESE GROUP SESSIONS HAD 134 PARTICIPANTSIN 2017.
