SHELTER - WE OFFER A CONTINUUM OF SERVICES FOR WOMEN, MEN, AND CHILDREN IN OUR SIX COUNTY SERVICE AREA. OUR PROGRAM SERVICE MIX IS DESIGNED TO ASSIST CLIENTS FROM CRISIS TO STABILITY. WE PROVIDE A CRISIS SHELTER FOR FAMILIES FLEEING THEIR HOMES DUE TO DOMESTIC VIOLENCE. OUR CRISIS SHELTER IS COMPRISED OF STAFF AROUND THE CLOCK ASSISTING CLIENTS WITH IDENTIFYING THEIR NEEDS, CONNECTING TO RESOURCES, AND PLANNING FOR A SAFE FUTURE. DURING 2019, 636 CLIENTS WERE ASSISTED THROUGH OUR PROGRAMS AT THE SHELTER. OUR TWENTY FOUR HOUR CRISIS LINE, WHICH HANDLED 2468 CALLS IN 2019, IS STAFFED WITHIN THE SHELTER PROGRAM.
